I, Bob Drumheller, Chairman of the Page County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, do hereby issue this notice and call for a Mass Meeting of the Page County Republican Committee to be held on Tuesday, February 27, 2018 at the Luray VFW located at 218 Veterans Ln, Luray, VA 22835, starting at 6:30 P.M with registration beginning at 6:00 PM for the following purposes:

1. Electing up to 635 Delegates and Alternates to represent the Committee at the Republican 6th District Convention which shall be held on May 19, 2018, at the JMU Convocation Center, 895 University Blvd, Harrisonburg, VA 22801, starting at 10:00 am. The Page County Committee shall have 127 delegate votes.
2. Electing a Chairman of the Page County Republican Committee.
3. Electing members of the Page County Republican Committee.
4. Transacting such other business as may properly come before the Mass Meeting.
5. Adjournment

Qualifications for Participation

All legal and qualified voters of Page County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election as Delegates and Alternates to the 6th Congressional District Republican Convention shall file a form, which is a written statement of intention, by mail or in person, to Connie Painter, 2017 Piney Hill Road, Luray, VA 22835. Candidates for delegate may also file in person at the mass meeting on February 27, 2018. The form for filing to be a candidate for Delegate to the 6th Congressional District Republican Convention is attached to this call.

Candidates for election to the office of Chairman of the Page County Republican Committee shall file a form, which is a written statement of intention, by mail or in person, to Connie Painter, 2017 Piney Hill Road, Luray, VA 22835. The form must be received no later than 5:00 pm, Tuesday, February 20, 2018. The form for filing to be a candidate for Chairman of the Committee is attached to this call. If only one candidate files for this office, that person will be deemed elected. No nominations will be accepted from the floor of the mass meeting unless no one pre-files for the office.

Voluntary Filing Fees for the District Convention

A voluntary candidate filing fee of \$20.00 is requested of each person standing for election as a delegate or alternate to the District Convention. Failure to pay the requested voluntary filing fee will not result in disqualification.

Registration Fee

There will be no registration fee to participate in the Mass Meeting.
